VI. Discuss Eventbrite Registrations and Review Number of Registered Participants

- There are 23 people registered for the retreat so far. Although this is fewer than anticipated, many Independent Living Centers (ILCs) were waiting for the State Budget to help them determine how many staff they would be able to send.
 - ILC Directors have reported that they will start asking participants to register. More registrations should begin filtering in over the next couple of days.

VII. Discuss Promoting the Retreat and Messaging to Encourage Attendance

- Some of the ILC directors are still questioning the value of the retreat, especially for staff that is not directly involved in core services and IL work.
 - ILCs did not receive the expected funding increase, and they are hesitant to spend extra money.
 - Funding should not be a concern; the WILN retreat is a SPIL goal, and the planning committee has been active for more than a year.
 - The retreat focuses on the philosophy of Independent Living, the WILN partnership, and direction of the IL movement in Wisconsin. Discussions held during the retreat will not be repeated at other venues like IL Days.
 - It is extraordinarily important that WCILC board members be present for these conversations, and both days of the retreat.
 - Staff that are not directly involved in work with consumers and/or the five core services should also be a part of this discussion.
 - Many who work in different departments do not feel that they are a part of the WILN network, and often feel that they are "left out" of the conversation.
 - Everything that ILCs do leads back to the IL philosophy and IL movement.
- To better promote the WILN Retreat, there must be more focus on how attending will benefit attendees, especially WCILC board members and staff who work outside of ILCs' IL departments.

 - The first future-oriented session is titled "The Future of IL –
 Systems Advocacy with a Unified Voice." This will be a discussion
 about how the mechanisms that WILN will be using to effect
 change on a systems level. This session is an opportunity for
 WILN Leadership to describe the new direction the IL movement
 in Wisconsin will be taking.
 - The second future-oriented is titled "What does the future of IL look like?" This will be an opportunity for WILN Retreat participants to discuss, provide guidance, and help shape how WILN will move the IL Movement forward.
 - o The third future-oriented is titled "SPIL: The IL Roadmap."
