VI. Discuss Progress on 2021-2024 SPIL Goals

- We have data for Quarter One of Federal Fiscal Year (FFY) 2024; data for Quarter Two will be available around April 30th, when the Quarter Two reports are due.
 - 6 of 8 Independent Living Centers (ILCs) have had at least 70% of their consumers successfully complete the goals in their Independent Living Plans.
 - At least 1% of the persons with disabilities have been served in 14 of 72 counties.
 - More counties have reached the 1% threshold in FFY 2024 as compared to the same time in FFY 2023.
 - Quality Indicators for Independent Living Services (QUILS) review will be moved to either the the week of May 20th or May 27th, 2024.
 - The ILCW Quarterly Meeting will be May 20-21, 2024.
 However, this should not impact the QUILS review.
- ILCW's logged training hours were less for Quarter 1 of FFY 2024 than Quarter 1 of FFY 2023. This was expected because there were no new council members who had orientation during FFY 2024 Quarter 1 and there were fewer webinars, workshops, and other training opportunities offered within the network and among State and National partner organizations. ILCW Program Coordinator expects a significant increase for Quarter 2.

VII. Discuss Progress on 2025-2027 SPIL Development

 The DRAFT 2025-2027 SPIL was approved by the ILCW Executive Committee. At this time, further changes must be made through the use of public comments. All changes will be made using the "track changes" function in Microsoft Word, per Administration on Community Living (ACL) guidance.

VIII. Review Public Hearing Schedule

- The public comment period is scheduled through April 30, 2024.
 - The DRAFT 2025-2027 SPIL was not available until March 8, 2024. For the required 30-day review period, the public comment period's start date was delayed until April 8, 2024. For the comment period to last the required 30-days, it must end May 8, 2024.
 - ILCW Program Coordinator will make the necessary updates to ensure that the DRAFT 2025-2027 SPIL comment period is open April 8, 2024 through May 8, 2024. See Action Item 1.
 - ILCW Program Coordinator will send all Notices of Public Hearing to the Independent Living Center (ILC) Directors and Assistant Directors after updating the public comment period information to reflect a May 8, 2024 end date. See Action Item 2.
- ILCW Program Coordinator has been working to secure American Sign Language (ASL) Interpreters and Communication Access Realtime Translation (CART) services for all three of the public hearings being held at ILCs.
- ILCs can expect 20 or fewer people to be present at each of the Public Hearing meetings.
- Newspaper announcements have been drafted and are scheduled to run March 27, March 28, and March 29, 2024. The announcements are scheduled two-weeks prior to their respective public hearing meeting dates.

- Kyle Kleist, ILCW Vice Chair, reported there are no updates for the Systems Advocacy group.
- Marci Boucher reported no updates for the Funding, Growth, and Expansion workgroup.
 - Jason Glozier, Executive Director, WCILC reported that there is concern regarding the decision not to provide an additional \$25,000 to WCILC.
 - Nearly all this funding is expected to be used for Independent Living (IL) days, QUILS reviews, and other activities directly related to the accomplishment of SPIL Goals.
 - Taking Part B funding from ILCs is not an acceptable option to cover the \$25,000.
 - ILCW may receive additional funding from some other sources. If this is the case, then the Council will adjust its funding to ensure that WCILC receives some additional funding for completion of activities related to SPIL Goals.
 - WILN as a network will continue to work on a solution which will be amenable to everyone. The public comment process will be used if changes need to be made to the 2025-2027 SPIL.
- ILCW Program Coordinator provided a brief update for the Administration group.
 - The group worked with ILCW Program Coordinator to finalize the DRAFT 2025-2027 SPIL Draft to ensure it was ready for the March 7, 2024 ILCW Executive Committee meeting.
- Jason Glozier, Execuitve Director, WCILC reported no updates for the Service Delivery, Growth and Expansion workgroup.
